Although certain ICOs have made the headlines by raising millions of dollars within minutes or hours, from an investor's perspective, participating in an ICO may pose significant legal risks.

A combination of interactive lectures, case studies, practical scenario trainings, role-play sessions, group discussion/sharing will be used in the seminar. Upon the completion, participants should be able to acquire the necessary Fintech, corporate finance, legal, compliance and regulatory professional knowledge and identify the common issues to perform their daily duties effectively.
